To protect your vacation, we do not overbook charter buses. In turn, we ask that you only reserve those spaces you are willing to pay for. Space is limited and reservations are available on a first-come, first-served basis and must be scheduled for the night before your pick up. Access to overnight motorhome accommodations in Forest City the night before the rental begins, at no additional charge, is only available for rental clients utilizing the charter bus transfer program.

All charter bus transfers must be paid by personal or cashier's check within 14 days of booking the Transfers, or your charter bus transfer reservation will be cancelled. Reservations cannot be moved. There will be no refund for charter bus transfer cancellations, no shows or late arrivals. Great Alaskan Holidays, Inc. is not responsible for Customer delays, or delay of Customer baggage, to the charter bus pick up area. Buses will depart when scheduled. In the unlikely event a Customer misses the charter bus; the Customer is responsible, at their cost, for acquiring alternate transportation to Forest City.

Customer releases and agrees to indemnify, defend, and hold harmless Great Alaskan Holidays, Inc., its agents and employees, from all claims for personal injury or death by Customer, his guests or invitees, arising out of Customer's use of the charter bus accommodations, and for the loss of or damage to personal property of Customer or any other person. Great Alaskan Holidays, Inc. shall not be responsible for any lost or damaged personal property, items left or carried in or upon the charter bus or any service vehicle, or on the premises of Great Alaskan Holidays, Inc. by Customer or other person, or received, handled or stored by Great Alaskan Holidays, Inc. at any time before, during or after the charter bus trip, whether or not due to Great Alaskan Holidays, Inc.'s negligence or fault. Great Alaskan Holidays, Inc. shall not be responsible for loss of time due to mechanical failures or inclement weather. Damage to the charter vehicle caused by Customer or other persons traveling with Customer, will be the sole responsibility of the Customer.

Customer agrees and acknowledges that Great Alaskan Holidays, Inc. is not an owner or operator of the charter bus and is not a common carrier, and is not responsible for the safe operation of the bus, or responsible for the bus driver, who is not an agent or employee of Great Alaskan Holidays, Inc. Great Alaskan Holidays, Inc. is acting only on behalf of Customer to arrange transportation at Customer's request, incidental to Customer's use of a Great Alaskan Holidays, Inc. motorhome. Customer acknowledges that other different modes of transport are available and that Customer has no obligation under any contract with Great Alaskan Holidays, Inc. to travel on a charter bus. Customer acknowledges having personal injury insurance coverage adequate for Customer's needs and purposes regarding travel on a charter bus, and shall look solely to such insurance in the event of any injury. The exclusive venue of any dispute regarding the charter bus shall be Alaska, to be resolved under Alaska law.

Great Alaskan Holidays, Inc. is not responsible (beyond refund of fees and deposits paid to Great Alaskan Holidays, Inc.) for having to cancel a reservation due to circumstances beyond Great Alaskan Holidays, Inc. control such as: actions of third party contractors or manufacturers, strikes, lockouts, riots and stoppage of labor from whatever cause, terrorist activities and/or acts of war or for any other reason beyond Great Alaskan Holidays, Inc. control. No smoking or animals are permitted in the charter buses. I understand that my signature acknowledges my agreement to the terms and conditions set forth in this and other accompanying documents.

"Customer" or "renter" in this form includes all persons accompanying them. All persons riding the bus must sign this form, by which they agree individually to the above terms and conditions. Any adult signer hereby assumes responsibility for any minor accompanying the adult.
